Project Stakeholder:

The Ohio Department of Transportation (ODOT) is proposing the construction of two single-lane roundabouts at the intersections of US 42 & SR 302 and SR 89 & SR 302. The construction of the roundabouts requires that all pavement on all four approaches of each intersection be replaced at full depth to account for new roadway alignments associated with the proposed roundabouts. The project is tentatively scheduled for a start date in February 2024 and will begin construction April of that same year.

We are going to implement roadway closures and detours for this project to minimize the project footprint, reduce costs, and promote safety, but we want your input to make the final decision as to whether it is best to detour traffic during construction or maintain traffic. The potential detours are attached, and we anticipate these detours to be approximately 180 days total.

We are gathering information to better meet the needs of local traffic and reduce inconveniences to the public. We would like to solicit from you any information regarding businesses, schools, fire department(s), churches, mail delivery, hospitals, cemeteries, resorts, festivals, county fairs, seasonal events and large farming operations that may be affected by the detour.

We will be using this information to plan for the roadway closure at a time when less inconvenience will be experienced by these facilities and activities.

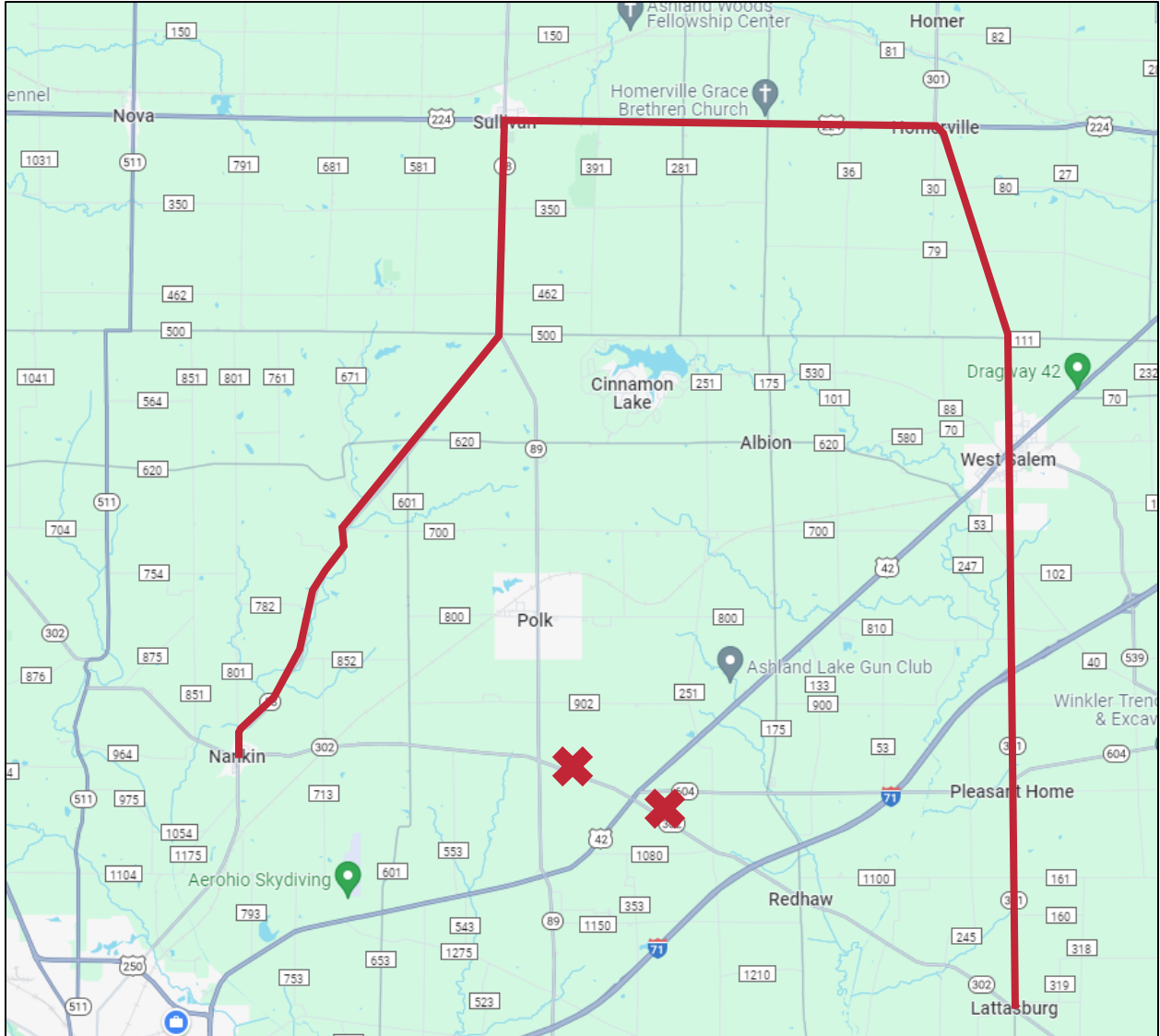

Proposed Detour PID 114065 & PID 114149 Ashland SR 302 in Calendar Year 2024 Phase 1 of Construction



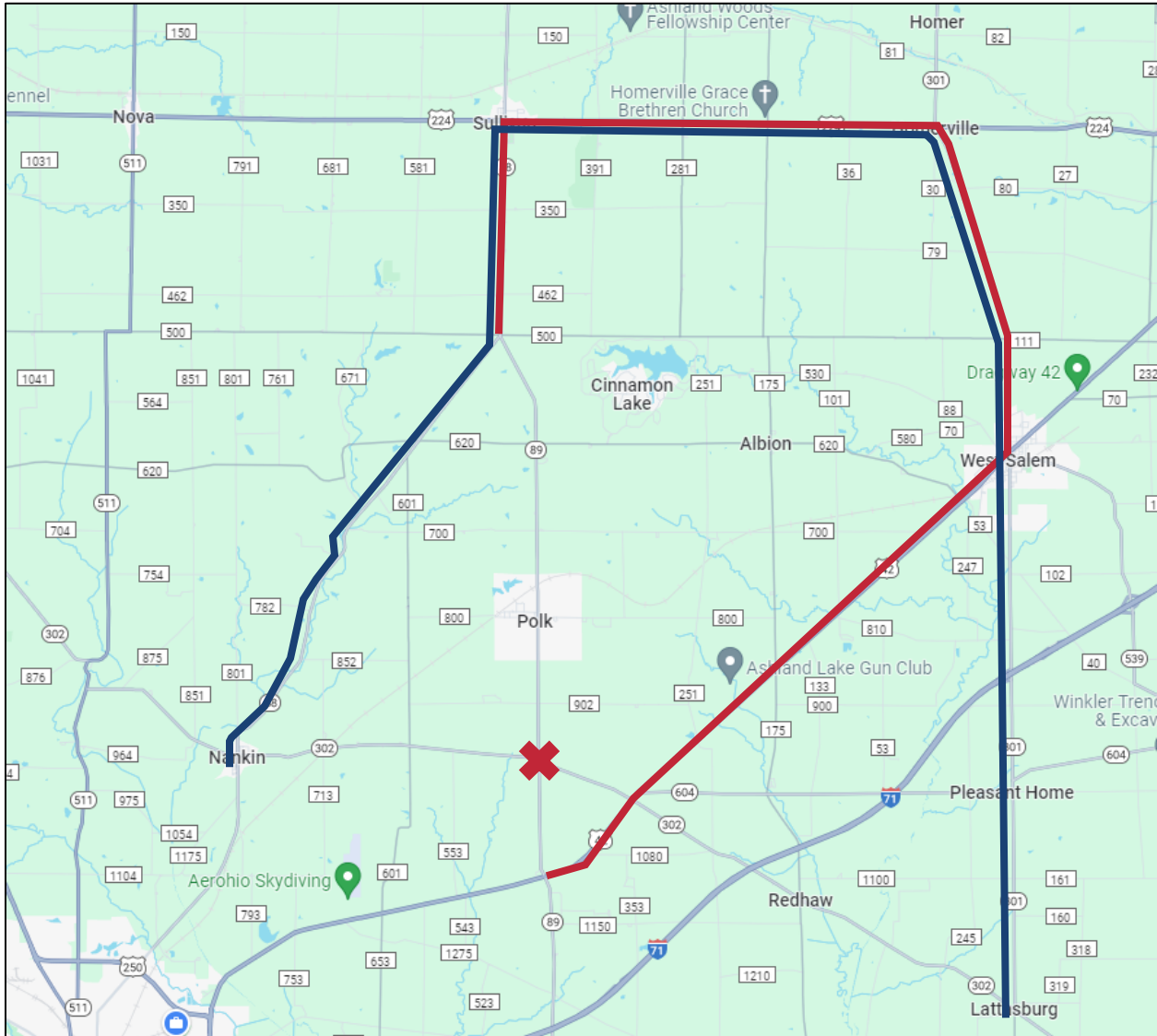
Construction: Construct the east legs of the SR 89 and US 42 roundabouts, then construct the remainder of the SR 89 roundabout, then construct the remainder of the US 42 roundabout

Detour Route: SR 302 – Eastbound is SR 58 north to SR 89 north to US 224 east to SR 301 south. Reverse for westbound.

Duration: Approximately April – September 2024



Proposed Detour PID 114065 & PID 114149 Ashland SR 89 in Calendar Year 2024 Phase 2 of Construction



Construction: Construct the remainder of the SR 89 & SR 302 roundabout.

Detour Route: SR 89 – Northbound is US 42 north to SR 301 north to US 224 west to SR 58 south. Reverse for southbound. The SR 302 detour from Phase 1 is still in-place.

Duration: Approximately June – July 2024
