3. Authorize the appointment of Abby Donofrio to the Ashland County Airport Authority, for a term from July 14, 2026 to July 13, 2030

5. Approve a resolution declaring the intent to proceed with the renewal of a three year 2.10 mill levy with an increase of 1.00 mill to constitute a total tax of 3.10 mill for the Ashland County Board of Developmental Disabilities for the purpose of providing funding for the operation of Dale-Roy School programs and facilities, to be submitted to the entire territory of Ashland County at the General Election to be held on November 3, 2026

7. Authorize the execution of the Discount Drug Mart Opioid Settlement Agreement, which will allow Ashland County to receive approximately \$18,988.77 in settlement proceeds

8. Approve the appointment of current employee Alexis Manning to the position of Social Service Worker 2 within the Social Services Ongoing Unit of the Ashland County Department of Job & Family Services, a bargaining unit position with no change in Ms. Manning's current pay rate, to be effective June 22, 2026, as recommended by Peter Stefaniuk, Director

9. Approve a contract between the Ashland County Commissioners, the Local Emergency Planning Committee, and the Ashland County Emergency Management Agency (EMA) to allow the EMA to provide disaster coordination services for Ashland County, and to further allow all grant funding that is received to be transferred into the county general fund

10. Authorize Then & Now Certifications and payment of warrants for soil & water

11. Authorize the approval of the 2027 Budget as tentatively proposed for Ashland County, Ohio
